Pursuant to the office No. 2156(19)/SLSA-115/2010(4), Dated: 03.08.2017 the **District Authority** invites application from the local residents having minimum qualification of **Matriculation or Higher Secondary examination passed or equivalent standard** from any Govt. recognized Board, with the **capacity for overall comprehension** and the mind-set to assist the needy in the society coupled with the compassion, empathy and concern for upliftment of the weaker and marginalized section of the society, maintaining the high level of integrity, morality and the discipline to abide by the rules and regulation existing for PLV's as per **revised scheme of NALSA**. The application are invited from the following **categories** as per guideline of NALSA:-

Category of persons eligible to apply for PLV(Para Legal Volunteer)

1. Teachers (including retired teachers)
2. Retired Government servants and senior citizens
3. M.S.W students and teachers
4. Anganwadi Workers
5. Doctors / Physicians
6. Students & Law Students (till they enroll as lawyers)
7. Members of non-political, service oriented NGOs and Clubs.
8. Members of Women Neighbourhood Groups, Maithri Sanghams and other Self Help Groups including of marginalized/ vulnerable groups
9. Educated prisoners with good behaviour, serving long terms sentences in prisons.
10. Any other person whom the District Legal Services Authority or Taluk Legal Services Committee deems fit to be identified as PLVs

It is hereby made clear that the **work of PLVs does not carry any salary, remuneration or wages except, 'honorarium' fixed by the DLSA (District Authority) / SLSA (State Authority) from time to time.**

For purpose of selection of PLV's the **District Authority** and the concerned **Recruitment Committee** reserves all their rights and prerogatives, using their own discretion, and same cannot be questioned any way nor any clarification can ever be sought for by any candidates under any existing laws, rules and regulation.

For the purpose of final selection of PLV's, the decision taken by the **District Judge-cum-Chairman, DLSA, South 24 Parganas** and the **constituted Recruitment Committee** shall be final and shall not be subject to any challenge or clarification under any forum.
