This Order of ' Legal Aid Clinic' duty for the mentioned PLV's is given effect to on and from 01/01/2014, and shall continue to remain in force , for the month of July to October 2016, or until further order

The functions of Para Legal Volunteers in the Legal Aid Clinics will be as follows;

- 1) They shall provide initial advice to the seekers of Legal Services; help such people, especially the illiterate, in drafting petitions, representations or notices and filling-up the application forms for various benefits available under the government schemes.
- 2) They shall, if necessary, accompany the seekers of legal services to attend the government offices for interacting with the officials and for solving the problems of such people.
- 3) In case of emergency, they may take the seekers of legal services in the legal aid clinic to the nearest legal services institutions.
- 4) They shall distribute pamphlets and other materials in aid of legal education and literacy to the seekers of legal services in the legal aid clinic
- 5) They shall take active part in the legal awareness camps organized by the legal services institutions in the local area of the legal aid clinic and
- 6) They shall also follow the instructions(s) as would be given to them , time to time by the District Legal Services Authority.
- 7) The said P.L.Vs shall be governed by all the guideline as envisaged in National Legal Services Authority (Legal Aid Clinics) Regulations 2011, as per Notification No. L/08/11/NALSA New Delhi, 18th August, 2011.
